



① 接地端子

接地端子はユーザーが製品に接触するときに発生し得る感電事故を予防するために接地線を接続する部分です。

② 電源コネクタ

電源ケーブルをネットワークスイッチの電源コネクタに接続します。本製品は電源ボタンがないため、電源を接続するとすぐに立ち上がります。


